The Federal Public Defender for the Northern District of Texas is accepting applications for a full-time Assistant Federal Public Defender (AFPD) in the Capital Habeas Unit (CHU). The CHU represents indigent persons on death row in Texas. Through an interdisciplinary team approach, we provide our clients with the highest level of legal representation challenging their convictions and death sentences. CHU attorneys regularly litigate in federal district court, the Fifth Circuit Court of Appeals, and the United States Supreme Court

What We Offer:

- Competitive Salary and Benefits: The position is full-time with federal benefits and salary commensurate with experience and qualifications. The starting salary for the position will fall within a range of \$96,343 to \$195,200 and varies based on experience. The position is excepted service and does not carry the tenure rights of the competitive Civil Service. Benefits include health and life insurance, retirement, the Thrift Savings Plan, and the Employee Assistance Program. Salary is payable only by direct deposit.
- Collaborative, Supportive Environment: This position will receive extensive support, both from office-wide and team meetings, as well as through our collaborative work culture.
- **Ongoing Education**: The AFPD will have access to internal, statewide, and national training opportunities.

Qualifications:

- Applicants must be a graduate of an accredited law school and be a member in good standing of the highest court in the state where licensed;
- A Texas bar license is preferred;
- Two years of prior practicing experience representing death-sentenced individuals during trial, direct appeal, or post-conviction proceedings is preferred;
- Fluency in Spanish is preferred;
- Strong writing skills;
- Ability to travel as required for the cases;
- Proof of U.S. citizenship or other employment eligibility is required;
- Appointment and retention is subject to a satisfactory background check.
